Terms and Conditions

DENPAC operates on a non-calendar contribution ("membership") year. The contribution year begins September 1 and ends August 31. On the standard 10-month automatic draft, your account will be debited from September through June on or around the 10th day of each month. If you begin the **DENPAC EZ Pledge Program** any time after the month of September, your total pledge will be divided by the remaining number of months and drafted accordingly. In the event your account cannot be charged, both the outstanding and current installment will be drafted the following month. The program will automatically renew your pledge each year until you cancel the service. The EZ Pledge Program is not to be confused with the **TDA Prepayment Plan** for annual membership dues. If you already contribute to DENPAC through the prepayment plan or through the annual dues statement, this monthly pledge would be in addition to those contributions.

I, the undersigned, consent and permit the Texas Dental Association to charge to the bank/credit card account specified in the previous section the amounts contributed by me to the Texas Dental Association Political Action Committee, DENPAC, for state political campaigns. I understand and agree that the Texas Dental Association may continue to draft such amounts from my account for 1/10th of the total amount beginning in September of each year and continuing thereafter until receiving 7 days advance notification from me that I withdraw my consent and permission, at which time the Texas Dental Association shall cease drafting any such amount from my account beginning with the next monthly withdrawal. In addition, I have read the disclaimer below and understand the restrictions on contributions to political action committees and that these contributions are not deductible for federal tax purposes.

Federal law requires political action committees to request and make best efforts to report the name, mailing address, occupation, and employer for each individual whose contributions aggregate in excess of \$200 in a calendar year.
